ALL STUDENTS DRIVING TO SVGS MUST OBTAIN AN SVGS PARKING TAG, WHICH MUST BE PROPERLY DISPLAYED IN THE VEHICLE WINDSHIELD AT ALL TIMES WHILE ON VCTC PROPERTY. Parking tag cost is \$25 for Waynesboro and RE Lee High School students. For Augusta County students, cost is included with fees paid at student’s high school.**

RULES/REGULATIONS FOR DRIVING/TRANSPORTING

I UNDERSTAND AND AGREE TO:

- ▶ Display a SVGS hang tag in each vehicle I drive and park in designated student areas.
- ▶ Complete and return this form **prior** to driving to SVGS/VCTC for any reason.
- ▶ Travel alone unless otherwise **requested and approved**.
- ▶ Transport a maximum of 3 riders if the law allows me to carry passengers (refer to Virginia’s Driving Manual for age limits). Failure to do so will result in the loss of driving privileges for a minimum of six weeks.
- ▶ Obey the **5 mph** speed limit at SVGS/VCTC and operate my vehicle safely at all times.
- ▶ Lock my vehicle while at SVGS/VCTC and leave the car and parking lot immediately.
- ▶ Arrive and leave at designated times, unless otherwise specified. Excessive absences or tardiness will result in loss of driving privileges. **I am considered tardy if I arrive to SVGS after 7:42 a.m.**
- ▶ Hold a valid Virginia State Driver’s License and with an approval to drive from my home school and parents.
- ▶ Accept any disciplinary action which may result from a failure on my part to adhere to these covenants. (These to include the loss of any further driving privileges and/or suspension from SVGS and the home school).
- ▶ **Vehicles on SVGS/VCTC property are subject to searches by SVGS/VCTC School Administration at any time while on school property.**
